Meeting Notes

1. Approval of previous minutes

- Charlie Brown moved to approve the minutes from the previous meeting and Gary Leslie seconded.

2. Business Arising from the previous minutes

- The Committee discussed rock for fill for the dam. An application has been submitted and Nova Scotia Environment (NSE) has all the information to process the request.

- The Committee requested an update scheduling a meeting with Provincial government representatives to attend a CLC meeting. AGC recently participated in a meeting with the Premier to discuss outstanding issues.

Action Item: Schedule a member from government to attend a CLC meeting

- The Committee discussed the state of Moose River Road from the mine site to Highway 224. The Committee discussed repair options and agreed that the most efficient method is to repair the road in sections by removing asphalt, followed by gravel addition and paving each section.
- The Committee discussed the Mooseland Community Centre, stating the information was obtained and the action item is now complete.
- The Committee discussed recruitment of a new committee member. The Chamber of Commerce in Sheet Harbour may be approached to assist finding a new member.

3. Project Updates

a. Touquoy Gold Project:

The Committee was provided an update of the Touquoy mine site operations. A Committee member inquired about the final depth of the pit. AGC stated that the current maximum pit is 35 m..

b. Cochrane Hill and Fifteen Mile Stream update:

The Committee discussed recent announcements and future plans for Cochrane Hill and Fifteen Mile Stream. Open houses were held for Fifteen Mile Stream and Cochrane Hill on March 3rd and 5th, 2018 in Sheet Harbour and Sherbrooke Nova Scotia respectively.

c. Beaver Dam Update:

The Committee discussed current activities at Beaver Dam.

The Committee discussed water sourcing for drilling operations. AGC is currently awaiting approval from Nova Scotia Environment (NSE), with a 60 to 90 day turnaround time.

The Committee discussed constructing a new mine road from Touquoy to Highway 224. AGC stated an application for an easement, lease or ownership of the existing logging roads will be pursued.

The Committee discussed the construction of a new bridge at Beaver Dam. AGC confirmed new bridges will be constructed and culverts installed as required.

4. New Business

- The Committee discussed traffic complaints received by AGC. AGC has a system in place to follow up on complaints, GPS units have been installed in all AGC vehicles and a shuttle bus has been provided for workers.
- The Committee inquired about obtaining a lunch wagon on site. AGC stated that one of the action items from the Musquodoboit Harbour Chamber of Commerce meeting was to provide a list of services required by the mine.
- A Committee member requested AGC representation at community events. AGC stated a representative can attend with sufficient notice.
- The Committee discussed prospective employment and the application process. AGC requires applications to be submitted online to ensure they are entered into the database.
- The Committee discussed water trapped between the crusher pad and the main highway. AGC stated a drain may be necessary and will look into drainage options.
Action item: Report drainage progress at next meeting
- The Committee discussed changes to the access road to site. AGC stated a new road will be in use as of April 13, 2018. The current road will be decommissioned, signs will be moved and a gate installed.
- AGC reported that a Moose River Museum Meet and Greet will be held on April 15th in Middle Musquodoboit. The museum would like someone from their organization to attend the CLC meeting to find out about the committee and promote the museum.
- The Committee members expressed interest in a model of the original mine. AGC will review this request and report back.
- The Committee inquired about booking a tour after the next meeting.
Action Item: AGC will provide a tour after the next CLC meeting
- AGC reported the old church steps have been located and a plaque will be installed this summer.
- A Committee member reported the Nova Scotia Small Business Initiative for the Eastern Shore will take place on April 18th, 2018 at 7pm in the old school in Musquodoboit Harbour.
